#### **CURRENT ISSUES OF RESEARCH**

## 1. "Water and sustainability: social representations and local communities"

The research deals with the sociological point of view some issues strongly related to the issue of sustainable management of water resources: 1) the centrality of the Community dimension in the perception of the problem; b) the relationship between local communities, institutional procedures and scientific and technological paradigms (the so-called expert systems); 3) the need to involve citizens in decisions concerning the water issue, through ways of participating in adequate territorial scale.

## 2. "The society widespreaded: organizations and policies"

Local actors are subjects of whole society, but the territorial variable redefines their action context (resources, relationships, opportunities and constraints). The aim of the research project is to analyze the contribution that various collective actors (public institutions, economic entities, third sector organizations) provide the government of the territory, with particular attention to social and environmental sustainability of local policies.

## 3. "Participation and urban policies: from cases to models"

Starting from some experiences of deliberative democracy imple in Piedmont, it is reflected inductively on possible models of participation for engaging experts, administrators and citizens in the public discussion on how to tackle urban problems.

# 4. "Local mobilization and public decisions to grips with the environmental and health risks"

The reconstruction of three exemplary cases of serious risks for the environment and health in Piedmont (asbestos pollution caused by the Eternit plant at Casale Monferrato, the rehabilitation of the Bormida Valley, urban mobility and traffic pollution) allowed to highlight the social and political vitality of local communities and the impact of processes of social mobilization on public policies: with particular attention to the demand for health and environmental quality coming from local communities involved and to the possibility that citizens's participation helps to activate processes of social and institutional innovation.

## 5. "Common goods: the participatory management of environmental resources"

The analysis deals with the complex and controversial issue of commons: a peculiar category of goods involving different decision-making and relational models as well the ownership entitlements among public, private and collective bodies. The common resources are an elective and problematic field for testing new organized forms of collective decision, because the management of environmental assets requires to take into account both the collective interests such as individual or categorical ones.
