Children's health, illness and care practices"

### 2. Doctor-patient relationship

In this field we should be included theoretical studies and research activities within the project "RoPHS - Report on the Piedmont Health System" inside the unit of the Department of Social Research (Scientific Manager Maria Luisa Bianco), and within the project on children's competencies in health and illness financed by the CRT Foundation.

### 3. Analysis of the monitoring, prevention and control practices of the pandemic diseases

In this field it is possible to include two researches in which I participated: the first, still in progress, financed by the Italian Ministry of Health and implemented in collaboration with the Venezians Zooprophyllactic Institute and the Department of Veterinary Sciences of the University Turin, and the second 'Building the public health in the productive practices: the application of the legislation on avian influenza in poultry farms in Piedmont ', with the University of Turin.
