### **CURRENT ISSUES OF RESEARCH**

The problem of liberty in Luigi Pareyson's thought

Pareyson's thought is a hermeneutics of liberty. The liberty is understood by him always as beginning and as choice, that is as indipendence and self-determination and as decision of an alternative. For this reason his conception of liberty assumes a dialectical configuration both about the nexus between time and eternity and about the relation between good and evil and it puts itself in the centre of a dialectical ontology of participatory and opposition incommensurability

## 2. K.W.F. Solger's ontology of revelation

K.W.F. Solger (1780-1819) elaborated in the wide context of the German Idealism a deep and autonomous Neoplatonic-Christian ontology, based on the concept of revelation of the unity of absolute in the duality of existence, which is not widely studied in the Italian context. In his writings he outlines a model of revelation in which idealistical necessity of creation and lutheran liberty of the redemptive incarnation live together in a tensive union.

## 3. Italo Mancini's philosophy of religion between metaphisics and hermeneutics

Italo Mancini's philosophy of religion takes shape in the passage from the neoclassical metaphisics and from a trascendent Being demonstrated by the reason to a hermeneutics of christian revelation centred on the importance of the historical liberation and on the oxymorical theo-logic of "double thoughts".

4. Metaphisics and hermeneutic among analogy, symbol and paradox

Nowadays philosophy is still called to think the Absolute. Metaphisics of principle and hermeneutics of verity think it by the different ways of analogy, symbol and paradox, understood above all in a philosophical and theological sense. One must show the nexus of identity and difference which exists between analogy and paradox in their reference to symbol and abyssal inexhaustibility of Absolute.
