Degree in Philosophy at the University of Turin with a thesis in the area of Industrial Sociology, then (1998-2008) research and teaching in Germany. He received his PhD in Social and Political Science at the University of Göttingen.

His research interests focused initially on the classical issues of Industrial sociology and sociology of work, particularly in the automotive sector, and industrial relations. He has also specialized in regional development and local development planning processes and was scientific coordinator of the participative process of strategic planning "[Cuneo 2020](#)" (2004-2012).

In 2008 he was guest researcher at the Research Department of the European Trade Union Institute (ETUI) Bruxelles and in 2014 visiting professor at the Cologne Center for Comparative Politics (CCCP) and the Department of Economics and Social Sciences (Wirtschafts- und Sozialwissenschaftliche Fakultät) of the University of Cologne.
