CURRENT ISSUES OF RESEARCH

1. Start up innovativa and equity based crowdfunding

Since crowdfunding is the main fundraising method used by start-ups and innovative enterprises, it is clear that the two topics are closely linked. The legislation on these issues is

constantly evolving and this is the reason why they are currently an interesting field of research.

2. Exit strategies for the partners.

In the Italian legal system, different are the exit strategies for the partners: in the case of partnerships, the sale of stock holdings is not usual, because the buyer would have a personal and unlimited liability also for the pre-existing legal obligations; in the case of corporations, the right of withdraw and the transfer of the shares are, however, the preferred methods. The two topics are part of the same researchfield.

3. Corporate governance and internal control systems

Nowadays, there are plenty of laws regarding the internal control systems on the management of companies, in particular of the listed and finance ones. Therefore, it seems necessary to identify those who are involved in the system and understand what kind of relationship is there between them, in order to find a solution to simplify the rules.
