CURRENT ISSUES OF RESEARCH

1. Endogenous Growth and Intellectual Property Rights

Endogenous Growth Models often assume full excludability of intellectual contents thanks to the Intellectual Property Rights System. Excludability involves both incentives to research and unintended effects due to monopolistic exploitation. The research aims at assessing the alternative between regulation through the management of intellectual property rights or via taxation and public expenditure.

2. Tax Evasion as a problem of social interactions among agents in the economic, political and territorial framework

A large body of literature has expanded our view of tax evasion starting from the classical contribution of Allingham and Sandmo 1970. Besides the classical factors considered as determinant in the field (income, age, gender, field of activity, morale, religion, etc.) also factors pertaining to social interactions, such as agency relationship, professional intermediation, political engagement, etc. seem to play an important role, that the research aims at describing and assessing.
