### CURRENT ISSUES OF RESEARCH

#### 1. Which Education? For which Lawyer?

This research began last year at the Institut d'Etudes Avancées of Paris. The thesis is that, in the light of the current crisis of modern legal paradigm, legal education should not so much aim at preparation of technicians with in-depth knowledge of positive law (usually national, as yet mostly the case), but should rather prepare culturally equipped lawyers (also in not strictly legal matters), able to understand and manage a law changing rapidly. Also in the method of teaching should pass the idea that the legal knowledge is not a truthful knowledge that provides certainty and that legal categories are the product of history, not universal and eternal dogmas.

#### 2. Criminal Law and Hermeneutics

In continental Europe, modern criminal law has been built on the foundations of legality and the exclusion of judicial law making. Its genetic code is thus incompatible with legal hermeneutics that set the judicial application of law at center stage and claiming a constitutive role for interpretation. The research retraces the difficult and agonizing path along which Italian criminal law community has opened to hermeneutics in recent years, laying the groundwork for the construction of a new scientific paradigm.
